Call to Order

The meeting was called to order @ 7:00pm by Council President Dawn Sitz.

Reading of Minutes

The minutes for the council meeting on 08/01/2022 were read for council approval.

Pool Complaint:

Robert Palmer and Chris Prost were present. They came to the council with concern about the pool music and multiple pool rules being broken. Chris presented copies of the rules with the broken rules highlighted. There was discussion on the concerns and issues going on.

Ron Fike was present to speak on behalf of the Rec Department. There was mention of only allowing the pool manager to create a playlist of music. It was stated that the bass is an issue.

The council will review the information for next year's pool season as this year's season is ending soon.

Police

Chief Seals reported for the police department. She presented the prior months activity report.

Justin and Falicity will be going to training the 22nd & 23rd for Understanding & Using Law to Catch Criminals in the Streets.

Shannon informed the council that she is currently speaking with the Chiefs from the other towns to get assistance when needed. She stated that it is currently in the beginning phase.

Shannon educated the council on the code process and procedures. She informed the council of how the police department handles each case. She told the council that she likes to educate the community and offer them help if they can not take care of it themselves. There was discussion and questions on the process.

Request for New AED pads: There was discussion on the need to replace the expired AED pads, there is concern about the pads being interchangeable with the paramedics so that they do not have to switch the pads. City Clerk or Chief will check to make sure they are compatible

before purchase. Motion to approve 4 youth pads and 4 adult pads after verifications of compatibility with the EMS for up to \$2000.00 by Seals, 2nd by Shreve, motion carried.

Shannon informed the council that there has been a request by a Jeep group to host a fundraiser for the Police Department and wanted to confirm that it was okay with the council for this to happen. The council would like more information on this.

Maintenance

Joshua was present for maintenance.

Joshua informed council that his and Jordan's training went well.

Joshua informed the council that maintenance was currently working on prepping Kansas Avenue for the chip seal.

There was a question on forwarding the Maintenance office line to the worker on duty cell phone in case of emergency, there was discussion on this.

Lister advised that there was a rather large pot hole on 1st and David.

Motion to approve the wastewater permit for \$185 by Seals, 2nd by Lister, motion carried.

Motion to allow Autumn to attend the League conference with hotel stay for two nights, 1 meal and mileage by Seals, 2nd by Moore, motion carried, Shreve abstained.

There was discussion on the Propane Central Contract renewal. Motion to accept the renewal for \$6142.09 by Shreve, 2nd by Seals, Motion carried.

Motion to reimburse Tyler Beckman for solar charger for fish feeder for \$27.53 by Shreve, 2nd by Lister, Motion carried.

Motion to approve extension requests by Shreve, 2nd by Lister, Motion carried

Motion to approve all paid bills by Shreve, 2nd by Lister, motion carried.
