The regular meeting of the Carbondale City Council was called to order at 7 pm by Mayor Towne.

Council present: Reynolds, Reed, Lister. Absent: Zerbe, Traphagan

Employees & visitors: Richardson, Kane, K Reynolds, Attorney DeVoe; Randy Piper, Larry & Kandy Hinck, Nick Trejo, Jeremy Gaston.

Minutes:

- 02-19-2013 read. Motion by Reynolds, second by Reed to accept as corrected. Motion carried.

Police: Kane

- Verbal department report
- Vehicle purchase, tabled until a full council is present.
- Discussion of training opportunities in Kansas.
- Training request for Klenda and Vogel. Klenda will receive regular pay to attend; Vogel is part-time and will pay own way. Room cost \$15 per room. Motion by Lister, second by Reed to send Klenda and Vogel to training at Camp Dodge, Iowa; pay one night lodging for both, per diem meals for Deb only and a car to get there, riding together. Motion carried. Reynolds stated he is for the training, but not the location.
- Discussion of increasing court cost. Chief stated the additional funds would pay for increase in the Judge's salary and digital tickets. Motion by Reed, second by Reynolds to increase court costs to \$85. Motion carried. A draft of the ordinance will be prepared for next meeting.
- Request to lease a Stalker handheld radar on lease at \$72.74 per month for 24 months. Purchase price \$1495. Discussion.
- Discussed electronic ticketing; cost \$490 per month for 2 units, includes supplies. There is a cost to interface to Jayhawk Court program.
- Radar and electronic ticketing tabled until next meeting. Chief to have itemized sheet on electronic ticketing.

Maintenance: Richardson

- Repaired a water main break today.
- Hinck stated the culvert installed at the new Casey's was made of plastic, which is not compliant with our ordinance. Sherwood is aware of the issue.

Library:

- Trejo gave report on library activities
- Informed the council there is an open position on the board and another will open in April

West Lake caretaker:

- Council reviewed a letter from George Raymond stating he resigned as of March 1, 2013 as the lake caretaker.
- Clerk is to advertize the position stating salary is negotiable.

- Motion by Reynolds, second by Reed for a 10-minute recess at 7:52 pm. Motion carried.
- Called back to order at 8:02 pm

- Motion by Reynolds, second by Reed to reschedule the Town Hall meeting for March 11, 2013 at 7 pm. Motion carried.

- Motion by Reynolds, second by Reed to pay all approved bills. Motion carried.
