Minutes for previous meeting:

Minutes read for Council meeting on 3/7/17.

Russ Mayfield- Cornerstone Church and Parsonage

Request for extension to pay bill for church (\$626.17) and parsonage (\$787.61). Pay \$450.00 on Tuesday 3/21/17 and make payments on both balances plus the current bill. Cross connection will not happen again.

• Motion by Hinck, 2nd by Poley to accept \$450.00 payment on account, turn on both meters, with monthly payments of \$160.63 plus the current bill for 6 months. Motion carried.

Ray Emory- high water bill.

Mr Emory requested that his bill be lowered, he didn't feel that he had used that amount of water that the meter showed. Also complained about the smell of the water, he is on the very end of the water line. He complained that they ran water through his meter to flush the line. Bretsnyder explained that the meter was flushed at the fire hydrant which did not affect his bill. Council made no change in bill after checking the reading records provided by the office.

The maintenance department was instructed to flush the line regularly.

Girl Scouts request to create a flower garden at the City Park. No one from the organization attended. No action taken. Request was tabled.

Police:

Chief Smith requested permission to attend the Transportation Conference 4/3/17-4/5/17. He should get 14-15 hours training credit. KLETC keeps a record of training hours. \$70.00 registration plus hotel.

Chief requested that the tree at the Police Dept be removed and a flag pole be installed. He will get prices for the next meeting.

Chief requested permission to have a shooting range out on the West Lake property. There is already a berm out there that would not need a lot of work. Maintenance Dept said they could get the work done out there without taking a lot of time. The PD could practice during the week and use the Os Co range for qualifying. This range is to be used by the Police Dept only.

Councilman Hinck went with Brad to inspect it. Asking price of \$15,500.00. They could use the old mower for rough areas and around rocks, it would shorten their mowing time.
