## Maintenance 1

Bretsnyder presented a bid for a new backhoe. It would replace the mini excavator. It would be used for many projects such as digging manholes, sewer lines and water lines. It is able to do a lot more than the mini excavator. He is getting more bids.

Discussion on the streets around the new subdivision. Big trucks are causing potholes and the roads crumbling. Bretsnyder has pushed ruble back into the holes. Moore suggested giving the big trucks a specific truck route up to the new development. A route was established using Main, Wilson, Lawrence Tucker and Clay so that additional areas were not affected.

Elevation was also discussed with Tucker Subdivision.

Buoys for East Lake were discussed. Bretsnyder will get a quote for five buoys.

Clutch on the tractor is \$6,594.85. Motion by Seals to repair the clutch on the New Holand tractor for \$6594.85, 2<sup>nd</sup> by Moore. Motion carried.

Moore had photos of the city park where repairs are needed including mulch. Flowerbeds are overgrown and need weeded. Maintenance can weed eat them if we are unable to find community members to help maintain them. Bretsnyder talked about using rubber mats under the merry-go-round and spinner.

## Security

ADT submitted a bid. Council had some questions so Stephen and Jessica were contacted via phone. Council had some concerns with cost and coverage. Clerk will get more information.

## **TRUTOUCH 70"**

K. Seals presented a 70-inch TRUTOUCH Unified Collaboration Display. It cost \$1,500 used from the State Surplus Store. It can video, annual trainings, Zoom meetings, court and more. Discussion on streaming meetings.

Motion by Ball to purchase 70-inch TRUTOUCH for \$1,500, 2<sup>nd</sup> by Moore. Motion carried.

Annual Training discussion. Question for attorney on how to keep record of completed group trainings.

#### **Park Committee**

Park Committee originally had 9 members; they are down to 5 members. Kelli Moore likes the idea of having a steering community recommended by Tom. Two people maximum come to the park meetings. A flyer was presented to get the community involved and to create a steering committee. K. Moore ideally would like the steering committee to not be city council members or Lions Club members. C. Moore is not apposed to a Lion being on the steering committee with the council making the final decision. Heather Garrison is a Lion and she can do grant writing. There are a lot of grants out there but they can not be completed without a plan. There currently is a 100% matching grant. An Engineer will

need to be hired. Game Time previously came out and looked and they are the ones with the 100% match. C. Moore took a list of what the community has recommended and incorporated it all into a drawing. Discussion was made about making a Facebook Post. There is used playground equipment available that would be delivered and installed. Discussion on companies adopting playground equipment. BNS might be willing to donate a fence or a train, clerk will check. Consensus to make a Facebook post to see if anyone would like to be on the steering committee for the park. Mayor asked about the flyer being the final meeting, if nobody shows up to the meeting then park plans will move forward. K. Seals asked if voting form could be linked to the flyer. Date on sample flyer is August 5, 2024 and will be updated two weeks out for the next council meeting. Park drawings are welcome. Walking path was discussed and C. Moore suggested taking the Bobcat out and making a six-foot path.
