Call to Order

The meeting was called to order @ 7:00pm by Mayor John Ryan.

Reading of Minutes

The minutes for the council meeting on 08/07/2023 were read for council approval.

Motion by Sitz, 2nd by Seals to accept minutes with corrections, motion carried. Moore Abstained.

Lions Club Event Requests

Kelli Moore came to the council to ask for permission to place porta potties by city hall and by the AT&T building.

Motion by Sitz to allow the placement of porta potties on 3rd street by City Hall and at the corner of 2nd & Main Street by the AT&T building 2nd by Lister, Motion carried.

The next request was to close 4th St. for the Parade from 4-5:30 from the school to Main St.

Motion by Sitz to close 4th St from the school to Main St. from 4-5:30 for the parade, 2nd by Lister, Motion carried.

There was discussion on having a joint public informational meeting regarding the city park expansion/remodel with the Lion's Club and the City. Motion to have a joint public meeting regarding the park development with the Lion's Club on October 10th at 7:00pm at City Hall by Sitz, 2nd by Lister, Motion carried.

Motion by Sitz to pay out comp time for Autumn, Dustin and Josh, 2nd by Lister, motion carried.

<u>Library Board member replacement request:</u>

Motion by Sitz to approve library board member request of Mary Gleason to fill open spot vacated by Patt Barr, 2nd by Lister, motion carried.

Police Department

Officer Kampsen presented an award to Maggie Davenport who assisted him with a medical situation.

There is no update on the camera installation for the park, but Shannon will reach out to him.

There was an update that Kreshel went to the Osage County National Night Out.

The new Durango was upfitted and stickered.

The chief mentioned multi-agency training with the other cities. The Chiefs are working to come up with a plan.

The Mayor asked about the status of the new radios, Shannon stated that she received an invoice each month but does not have an update. The mayor stated he heard something about an October/September timeline.

The police department is looking for grants to help fund the purchase of new body cameras.

Maintenance
