### **Police Department**

Officer McNary reported for the department.

A new case log for 1/1/16-1/18/16 was given to the council.

Rebecca Sinclair will get her inventory turned in soon.

The Chief of Police position is no longer on the KPOA website.

Feliciano has not started working yet but will be contacting Kayla soon.

City Office is to take care of KS-CPOST reporting until there is a Chief to take it over.

#### **Maintenance Department**

The Maintenance Department moved an old heater to the filter room to help with the heating problems they have experienced in past years. It is keeping the room at 60 degrees.

Changes made at the plant seem to be working to help the TOC readings. Richardson thinks the water will be in compliance unless there is a lot of moisture.

Waiting for Pro-clean was to be in town this week.

Extreme cold weather has kept Insituform from coming into town today. Richardson expects to see them this week, he knows of 7 taps not fully open.

Hinck asked if he knew what happened to the exhaust fan from the Kitchen. Maintenance has installed that in the maintenance shop.

The email for the Christmas decorations has not been sent out yet. Maintenance has taken the pictures and turned them in to the office.

### CDBG Special Round- Community improvements to City Park & sidewalks

Karen Weathers of BG Consultants spoke to the council about budget concerns and options for the shelter houses and ADA restrooms. Also spoke to the council about not having railings for the sidewalk on south main.

- 1. Stand alone restrooms with a red metal roof, split face masonry, no water heater (to be winterized)
- 2. One Stand alone shelter house with red metal roof
- 3. One Gazebo-type shelter house
- 4. No railing for sidewalk on Main St Weathers noted that it was not ADA requirement

Sitz asked if the small parking lot had to be paved. Weathers thought that 2 handicapped spaces would meet the requirements. She would need to check with the architects. Suggested that we get multiple options.

The sidewalk on Wells St next to the school- the crosswalk placement is causing problems and ask if the council had any ideas. Could add striping or signage.

Property Lines at the East Lake – poles are still placed on city property. City has three options

- 1. City person can speak to the landowner in person
- 2. City can send a certified letter to the landowner
- 3. City can file a suit against the landowner.

Mayor suggested that Atty. DeVoe send a certified letter to the landowner asking them to remove the poles within 60 days. They can remove them or the City will remove them at the landowner's expense. Council in agreement.

The poles have creosote on them that would affect our TOC readings.
